CALL THE MEETING TO ORDER

The regularly scheduled meeting of the Huntington Township Board of Supervisors was called to order by Chairman Dave Boyer With Supervisors Paul Guise and Jeff King present. Mr. Boyer said unfortunately the recording system for YouTube is not functioning.

PLEDGE OF ALLEGIANCE

Mr. Boyer led us in the Pledge of Allegiance.

MOMENT OF SILENCE

Everyone present observed a Moment of Silence.

PUBLIC COMMENT

Marie DiGangi is disappointed that the livestream is not working. Mr. Boyer agreed.

SECRETARY/TREASURER'S REPORT

1. Approve January 6, 2025 BOS Organization Meeting Minutes – Draft minutes of the January 6, 2025 BOS Organization Meeting were previously distributed to the Supervisors for their review. Supervisor King made a motion to approve the minutes of the January 6, 2025 BOS Organization Meeting as distributed. Mr. Guise seconded the motion and it carried.
2. Approve the minutes of the January 6, 2025 BOS regular business meeting - Draft minutes of the January 6, 2025 BOS regular business meeting were distributed to the Supervisors for their review. Mr. Boyer made a motion to approve the minutes as distributed. Mr. Guise seconded the motion and it carried.
3. Approve the Bill List for February 13, 2025 - The Bill List for February 13, 2025 was previously distributed to the Supervisors for their review. The General Fund bills amounted to \$60,549.09. The American Rescue Plan Fund bills amounted to \$185,871.00. There were no State Fund bills. Total expenditures were \$246,420.09. Mr. Boyer made a motion to approve the Bill List as distributed. Supervisor King seconded the motion and it carried.
4. Acknowledge the Financial Report for February 13, 2025 – Mrs. Davis read the Financial Report for February 13, 2025. The General Fund has a balance of \$795,981.64. The American Rescue Plan fund has a balance of \$30,795.27. The Liquid Fuels Fund has a balance of \$125,802.05. The total of all the funds is \$952,578.96. The Supervisors acknowledged the Financial Report for February 13, 2025.
5. Miscellaneous – Just a reminder to everyone the Bermudian Springs 4H Club meets here the third Thursday of every month, and new members are always welcome.

ROADMASTER'S REPORT

Roadmaster Chuck King said the Greenbriar Road Culvert is sitting on its foundation.

The new truck chassis is at US Municipal in Huntingdon, PA where the body will be affixed.

SUPERVISORS REPORT

Mr. Boyer said UCC Inspector Gary Shaffer has inspected the building for ADA Compliance and will make a written report.

Mr. Boyer said PennDoT will be performing engineering and traffic studies at the intersection of Carlisle Road and the Idaville York Springs Road.

Mr. Boyer said COG is discussing Broadband for the County.

ZONING OFFICER'S REPORT

Mr. Fridenvalds has issued the following permits since the January 6, 2025 BOS meeting: Dennis Rudolph – replacing siding and walls on four turkey barns; Kirby and Krista Martin – rebuilding laundry room and kitchen; Garman Homes – building two (2) two story single family dwellings; Joseph Sanders – rooftop solar panels; Martin Dayberry – adding a garage; Adam Raver – build a single family dwelling; and 4JFarm LLC – to subdivide a two acre lot.

Mr. Fridenvalds said 4J Farm on Cranberry Road is subdividing a two acre lot.

Mr. Fridenvalds said he is working on a FEMA Floodplain Report and they asked what Huntington Township is doing to mitigate heavy rain.

Weather is holding up progress for LCDM.

Flowing Springs is down to one vacant lot. Tammy Drive is not dedicated to Huntington Township yet. We do not remove snow there.

Due to weather conditions, Waste Management is not making all their pick-ups. Waste Management is assessing the situation.

ENGINEER'S REPORT

Engineer Scott Longstreth submitted the following report:

1. Greenbriar Road Culvert Replacement Project – Construction continues.
2. Myerstown Road Culvert Replacement – he received comments from PADEP after 2.5 months. He updated the plans and resubmitted them. Depending on when we receive approval, anticipated bid date April 2025.
3. Update to SALDO – on going. He is working with Andrew at ACOPD on the next section.
4. He received a call from ACCD that stormwater management controls weren't installed at E & B Clearing 270 White Church Road. He will look into it.
5. Plans being reviewed – JVI Group, Inc – board action required by 5/18/25. JVI received approval from ACCD so the plan can be placed on the next Planning Commission agenda for action.
6. At the request of HTPC, he performed a site inspection of JVI 2/4/25. Work is progressing according to the plan.

At this point, Jesse Rothenhaver from Weirman's Mill Road said he has a complaint about neighbors run off water coming onto his property and their retainion pond is leaking. He already spoke to Engineer Longstreth about it. He asked what he should do. Mr. Boyer asked Solicitor King to look into it. Mr. Fridenvalds said the pond is leaking water. Mr. Rothenhaver said it is affecting his chimney.

3. Review and Approve Rolling Road Culvert Replacement Progression – Roadmaster Chuck King said the Road Crew will be working on it soon.
4. Determine Amount of Road Salt Required for the 2025-2026 PennDoT Salt Contract – Roadmaster Chuck King suggested 100 tons. A motion was made by Supervisor King to order 100 tons. Mr. Guise seconded the motion and it carried.
5. Acknowledge Receipt of Auditor General's Fire Company Audits – The Supervisors acknowledged receipt of the 1/1/21 to 12/31/23 Audit Reports for York Springs Fire Company Volunteer Fire Relief Association and for Bendersville Fire Company VFRA as well.

NEW BUSINESS

1. Determine Attendees to PSATS Conference May 4 to May 7 for Registration – Supervisor Dave Boyer and Road Crew members Chuck King and Chad Asper will attend the conference as per a motion by Mr. Boyer, and seconded by Supervisor King. The motion carried.
2. Acknowledge Receipt of ACCD Approval Letter to EB Clearing, Inc for Renewal of NPDES Permit – The Supervisors acknowledged receipt of the ACCD Approval letter to EB Clearing for renewal of their NPDES permit.
3. Discuss and Take Action on Appointment of Open Records Officer – Supervisor Jeff King made a motion to have Chairman David Boyer replace Patricia Davis as Open Records Officer. Mr. Guise seconded the motion and it carried. Mr. Boyer said there will now be a separate Open Records Officer email address. Marie DiGangi commented:
